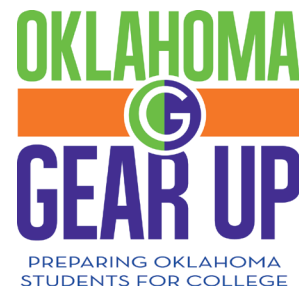


# Oklahoma GEAR UP

## GRANT GOALS AND OBJECTIVES



### Increase the academic performance and preparation

- Percentage of GEAR UP students who pass pre-algebra by the end of 8th grade will increase 3% each year for a total of 21%.
- Percentage of GEAR UP students who pass Algebra I by the end of 9th grade will increase 3% each year for a total of 21%.
- Percentage of GEAR UP students who take three years of math beyond Algebra I by the 12th grade will increase 2% each year for a total of 14%.
- Percentage of GEAR UP students on track for graduation at the end of each grade will increase 2% per year for a total of 14%.



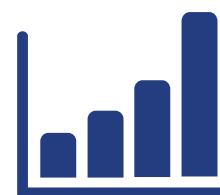
### Increase the rate of high school graduation and enrollment in postsecondary education

- Percentage of GEAR UP students who are on track to apply for college as measured by completion of the ACT by the end of 11th grade will increase to 95% in year one and remain at that level throughout the grant.
- Percentage of GEAR UP students who graduate from high school will increase 2% per year for a total of 14%.
- Percentage of GEAR UP students and former GEAR UP students who are enrolled in college will increase 3% per year for a total of 21%.
- Percentage of GEAR UP students who place into college-level math and English without the need for remediation will increase 3% per year for a total of 21%.
- Percentage of current GEAR UP students and former GEAR UP students enrolled in college who are on track to graduate college will increase 3% per year for a total of 21%.

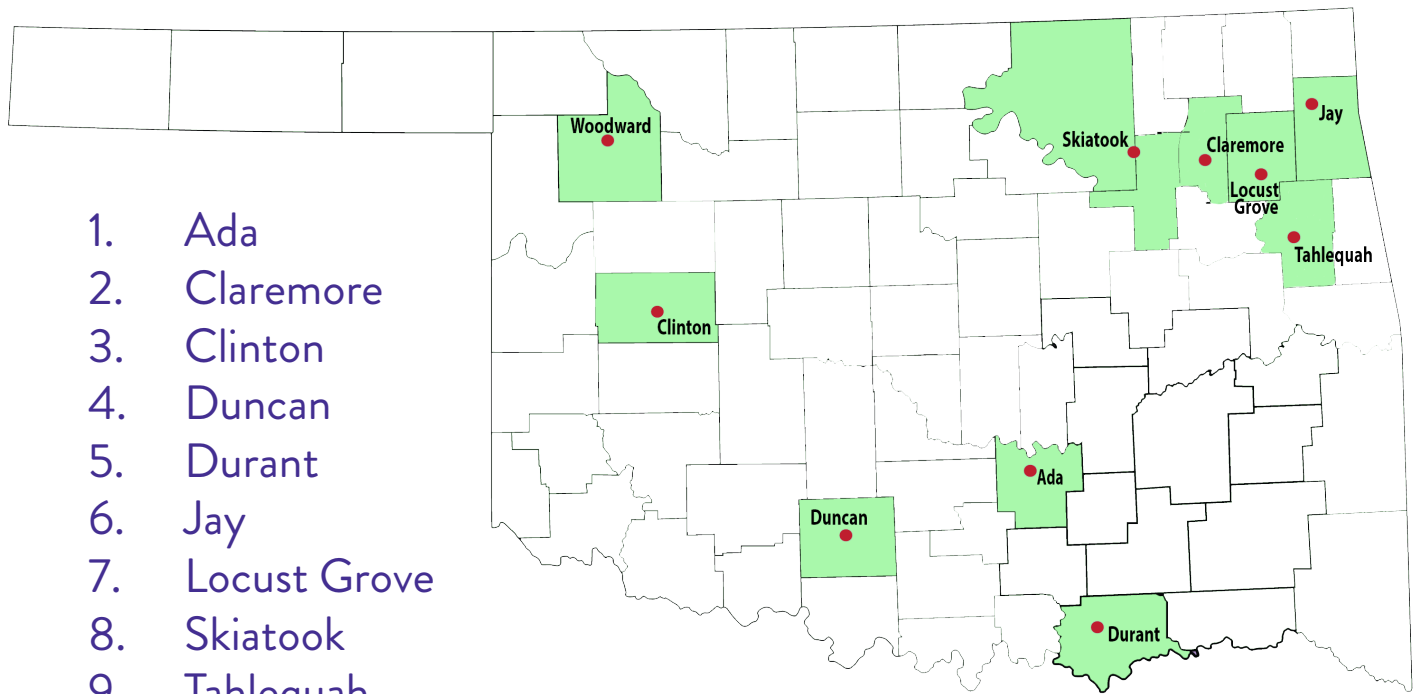


### Increase student and family knowledge of postsecondary education options, preparation and financing

- Percentage of GEAR UP students who complete the FAFSA will increase by 5% per year for a total of 35%.
- Percentage of GEAR UP students' and families' knowledge of postsecondary education options, preparation and financing will increase by 5% per year for a total of 35%.

The U.S. Department of Education awarded Oklahoma with a state GEAR UP grant totaling \$20.5 million in 1999. The grant was supplemented with a one-year extension of \$4.4 million in 2004. Oklahoma received additional GEAR UP grants totaling \$20.6 million in 2005 and \$34.9 million in 2011. In September 2017, the State Regents were awarded a fourth, consecutive GEAR UP grant in the amount of \$24 million over the next seven years.
